# DECISION ON CASE 003 DEFENCE'S URGENT REQUEST TO ACCESS THE CASE 004/2 APPEAL HEARINGS

THE PRE-TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia,

**BEING SEISED OF** the "Case 003 Defence's Urgent Request to Access the Case 004/2 Appeal Hearings", dated 6 June 2019 (the "Request"); 1

**NOTING** that the Pre-Trial Chamber ordered, on 3 June 2019, that a hearing shall be held on 19, 20 and 21 June 2019 on the Appeals lodged by the parties of Case 004/2 against the Closing Orders;<sup>2</sup>

**NOTING** that MEAS Muth's Defence requests to observe the proceedings and be provided with the relevant transcripts of the Pre-Trial Chamber's hearing on appeals against Closing Orders in Case 004/2;<sup>3</sup>

**CONSIDERING** that MEAS Muth's Defence is not a party in the instant case and consequently its presence is not permitted in the courtroom during the hearing on appeals against Closing Orders in Case 004/2;

**CONSIDERING** that the Pre-Trial Chamber will decide in due course the appropriate classification of the transcripts of the Chamber's hearing on appeals against Closing Orders in Case 004/2, in accordance with the Practice Direction on Classification and management of Case-related Information;<sup>4</sup>

#### THEREFORE, THE PRE-TRIAL CHAMBER HEREBY:

**REJECTS** the Request in its entirety.
