TRIAL CHAMBER III ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal"),

NOTING the motion to admit evidence related to Witness Zoran Buntić, filed by Counsel for the Accused Prlić ("Prlić Defence") on 21 July 2008¹ ("Motion") in which the Prlić Defence requested, *inter alia*, the admission of Exhibit 1D 01601,

NOTING the Order Admitting Evidence Related to Witness Zoran Buntić, rendered by the Chamber on 1 September 2008 ("Order of 1 September 2008"),

CONSIDERING that with regard to Exhibit 1D 01601 requested for admission by the Prlić Defence, the Annex attached to the Order of 1 September 2008 is marked as follows:

"Not admitted",

CONSIDERING that Exhibit 1D 01601 was already admitted by the Order on Requests to Admit Evidence Relating to Ciril Ribičić dated 15 January 2008,

CONSIDERING consequently that in the Order of 1 September 2008, the Chamber should have indicated that the request to admit Exhibit 1D 01601 was moot and the Annex should thus be corrected in this regard,

FOR THE FOREGOING REASONS,

PURSUANT TO Rules 54 and 89 of the Rules of Procedure and Evidence,
