I, CARMEL AGIUS, Judge of the Appeals Chamber of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Appeals Chamber" and "Tribunal", respectively), and Pre-Appeal Judge in this case,¹

NOTING the Judgement rendered by Trial Chamber II on 23 February 2011;²

CONSIDERING that, pursuant to Rule 65*bis*(B) of the Rules of Procedure and Evidence of the Tribunal ("Rules"), a status conference should be convened within one hundred and twenty days of the filing of a notice of appeal and thereafter within one hundred and twenty days after the last status conference, to allow any person in custody pending appeal the opportunity to raise issues in relation thereto, including the mental and physical condition of that person;

NOTING that Vlastimir Đorđević is currently in custody at the United Nations Detention Unit in The Hague;

CONSIDERING that the parties are expected to file their notices of appeal, if any, no later than 24 May 2011;³

CONSIDERING FURTHER that it is in the interests of justice that a status conference be held earlier than one hundred and twenty days of the filing of any notices of appeal;

PURSUANT TO Rules 65bis(B) the Rules;

HEREBY ORDER that a status conference shall be held before me on Monday, 30 May 2011 at 14:30 in a courtroom to be announced by the Registry of the Tribunal.
