SEISED of the "Public with Confidential Annexes A and B Urgent Defence Motion for Adjournment of Trial Start-Date due to Inability to take Instructions from the Accused, Charles Ghankay Taylor", filed on 12 June 2009 ("Motion"), wherein the Defence requests an adjournment of the Defence case on 29 June 2009, on the ground that access between the Accused and his Defence Team has been limited due to the outbreak of a "legionellosis bacterium" in the ICC detention facility;

NOTING that the Defence case is scheduled to start on 29 June 2009;

CONSIDERING THEREFORE that an urgent resolution of this matter is in the interest of justice;

PURSUANT to Rules 7(C), 26bis, and 54;

## **HEREBY ORDERS** as follows:

- (1) Any Response to the Motion shall be filed not later than 4:00pm, Monday, 15 June 2009;
- (2) Any Reply to the Response shall be filed not later than 4:00pm, Tuesday, 16 June 2009;
- (3) That CMS should accept this filing outside the usual filing hours and ensure immediate distribution to the Parties and the Trial Chamber of hard copies of this Order and any response or reply;
