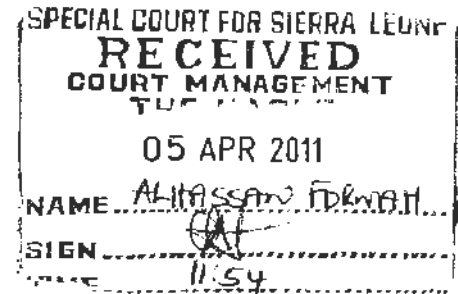

1. On 4 February 2011, the Prosecution filed the "Public with Confidential Annex Motion to Substitute Prosecution Final Trial Brief"<sup>1</sup> which the Trial Chamber accepted in an oral decision on 7 March 2011,<sup>2</sup> as confirmed by the Trial Chamber's Order of 18 March 2011.<sup>3</sup>
2. The Prosecution notes that there is an editorial error on page 277, paragraph 610 of the Prosecution Final Trial Brief. The last sentence of paragraph 610 states: "Moreover, even if the objective and character of an operation is itself legitimate, this does preclude criminal liability where the Accused is aware of the substantial likelihood that the plan will result in a crime." This sentence should read as follows: "Moreover, even if the objective and character of an operation is itself legitimate, this does not preclude criminal liability where the Accused is aware of the substantial likelihood that the plan will result in a crime."
