SEISED of the "Public with Confidential Annexes A to E Urgent Prosecution Motion for the Re-Filing of the 'Public Version Defence Final Brief' and 'Public Version Defence Response to Prosecution Final Trial Brief'", filed on 12 April 2011 ("Motion");¹

NOTING that the Prosecution requests an expedited filing schedule;²

CONSIDERING that, given the urgency of the matter, an expedited timetable for filings is warranted;

CONSIDERING FURTHER that the Public Defence Final Trial Brief and the Public Version Defence Response reveal the identities of protected witnesses and therefore should be immediately reclassified as confidential;

PURSUANT to Rules 7(C), 26bis, and 54 of the Rules;

HEREBY ORDERS THAT:

- (1) the Court Management Section re-classify the Public Version Defence Final Trial Brief and the Public Version Defence Response to Prosecution Final Trial Brief as Confidential pending the Trial Chamber's decision on the Motion
- (2) the Court Management Section notify all persons on the dissemination list who received the Public Defence Brief and Public Defence Response that such documents have been reclassified as confidential and that they should refrain from any onward distribution of these documents;
- (3) Any Response by the Defence shall be filed no later than 16:00 on Monday, 18 April 2011;
- (4) Any Reply to the Response by the Prosecution shall be filed no later than 16:00 on Wednesday, 20 April 2011.
