CONSIDERING the request of the Press and Outreach Officer of the Special Court for Sierra Leone to authorise Mr. Peter Dejong of the Associated Press Photo Desk in Amsterdam, The Netherlands, to take photographs before the start of the oral hearing in the Charles Taylor appeals on Tuesday 22 January 2013;

PURSUANT to Rule 81(D) of the Rules of Procedure and Evidence ("the Rules");

ORDERS AS FOLLOWS:

- 1. Mr. Dejong is granted permission to photograph from inside the Courtroom on Tuesday 22 January 2013 for one minute, before the start of the oral hearing in the Charles Taylor appeals;
- 2. He is to ensure that the dignity of the proceedings is preserved;
- 3. As the only photographer who will access the Courtroom, he agrees to make available the photographs taken to the press in Sierra Leone and the international press;
- 4. He will supply the Press and Public Affairs Office of the Special Court with all pictures so taken for internal use.
